## **Treasurers Report for Season 2011/2012**

I would like to remind you that the Loch Leven Curling Club constitution states that the financial year of the club is to the 30<sup>th</sup> April.

I hope that the accounts before you are fairly self explanatory.

At last year's AGM we had not yet reached the first annual reporting date of 30<sup>th</sup> April 2011 therefore I had projected forward the likely Income and Expenditure figures. I then gave a detailed outline of each item of the Projected Income and Expenditure report.

This year; as the Income and Expenditure report is the actual audited accounts to 30<sup>th</sup> April 2011 the report I would normally give would be the same as last year. As a consequence I would just like to point out that the closing balance was a healthy £983.97.

For this year I have again projected the accounts forward to the 30<sup>th</sup> April 2012 giving a closing balance down to £234.76. The reduction in the balance is due to a number of factors as follows:-

Although this season's Ice cost had increased by 5% the members ice fees were held at the same level as the previous season. This year the Club purchased 100 Lapel Badges costing £315.78 along with 2 new trophies and prizes totalling £238.03.

Finally, I would like to take this opportunity to thank Bill Linton for auditing the accounts.
